# terms & conditions 2008-2009

## Conditions Of Contract

Please read carefully the Terms and Conditions of contract as outlined below.

**1. How to Book:** To participate in a YOTS Explore Timor Leste 2009, you must pay a non refundable registration fee of AUD\$500 including GST which must be made payable to Youth Off the Streets Ltd and must accompany this Booking Form. You must also undertake to pay the outstanding amount (total less \$500 registration fee). Cheques/money orders should be made payable to Youth Off The Streets Ltd.

**2. Payments and Fundraising:** Eligibility to take part in any of the YOTS Explore Timor Leste is contingent upon you raising the minimum fundraising target as set out by YOTS (\$5000). Payments must be made to Youth Off The Streets no later than 60 days prior to your departure. These payments are based on arrangements departing from Darwin. There may be some additional charges if you are originating from an alternate Australian city. Registered participants will be required to cover additional travel or accommodation costs required as a result of departing from an alternative destination. Failure to lodge the contribution to Youth Off The Streets on or before the required date will render you ineligible to depart in the 2009 YOTS Explore Timor Leste departure and you will forfeit in full the AUD\$500 registration deposit paid to Youth Off The Streets and your place on the trek. All monies raised in the name of Youth Off The Streets must be forwarded immediately to Youth Off The Streets.

**3. Amendments:** If you wish to alter any of your arrangements, you should notify World Expeditions in writing and the changes will take effect upon receipt by World Expeditions. Any amendment will incur a \$50 administration fee per amendment. By definition, an amendment is any change that you make to your booking once your registration has been received.

## 4. Cancellations and Transfers:

If you wish to cancel your tour, you must notify Youth Off The Streets in writing and the following charges will apply: You will automatically forfeit your registration deposit (AUD\$500) and 100% of monies paid to, or fundraised for Youth Off The Streets.

Transfer from a 2009 departure to a 2010 (or later) departure is not permissible. The funds raised can not be transferred to another fundraiser. Should there be too few people booked on your departure, we reserve the right to cancel the trip. In this event, assuming that you have raised the full amount you will be offered an alternative departure (date or destination) and will not be entitled to any refund.

**5. Travel and Fitness Requirements:** You must be at least 18 years old prior to departure to participate. We recommend that participants are healthy and active. Upon registration, you will receive a questionnaire to be completed and returned by you. If however, you have pre-existing medical conditions or are in excess of 60 years, you are required to have the medical form completed by your doctor. The medical form is proof that you are fit enough to undertake the trip. If you suffer from severe muscular, chest, heart or bronchial disorders, are a severe asthmatic, or have high blood pressure, you are strongly advised against participating. If you fail your medical, a full refund of your registration fee will be given, providing you return the medical questionnaire within two weeks of registration.

**6. Delays or Change of Itinerary:** It is possible that a route change, postponement or delay may become necessary in Timor Leste or Australia during travel en route. This could be due to airline reschedules, inclement weather, political restrictions or any other cause. In the event of a change, postponement or delay, participants have no right to refund of the tour price (in whole or in part) or other compensation for any injury, loss or damage. World Expeditions also reserves the right, in its absolute discretion, to cancel any tour due to any government travel warning or advice, or any change in such warning or advice. In this event condition 4 applies in respect of the cancellation or transfer of a tour. Travel insurance may compensate you depending on the circumstances.

If there are too few participants on your departure for the trip to operate, and there is no alternative you will be given a refund of your registration fee (\$500). You will not be entitled to make any further claim for any injury, loss, expenses or damages (either direct or consequential) or for any loss of time or inconvenience, which may result from such cancellation (including but not limited to visa, passport and vaccination charges, gear purchases, airport and airline taxes).

**7. Force Majeure:** If World Expeditions is prevented (directly or indirectly) from performing any of its obligations under this agreement by reason of act of God, strikes, trade disputes, fire, breakdowns, interruption of transport, government or political action, acts of war or terrorism, or for any other cause whatsoever outside World Expeditions reasonable control, World Expeditions will be under no liability whatsoever to you and may, at its option, by written notice to you either cancel the tour or take any other action as specified in clause 6.

**8. Airline:** The tour cost includes international fares. These terms and 'Conditions of Contract' are not issued on behalf of, and do not commit, any associated airlines whose services are used or proposed to be used in the course of the trip.

**9. Insurance:** Personal travel insurance is not included in the tour price and is a compulsory requirement of your participation. It is strongly recommend that you take out travel insurance with World Expeditions when you pay your travel cost deposit.

**10. Package Prices:** Travel costs are based on ground costs, airfares and exchange rates at 1 August 2008. While we try our utmost not to increase our prices, sometimes it is outside our control. We reserve the right to amend our prices without notice, at any time up to and including the day of departure of any trip, in the event of exchange rate fluctuations, increases

in fuel costs, airport charges, airfares or increases in ground operator service fees or any other that are outside of our control. We ask you to confirm the total price with us before you book or pay your balance.

**11. Visas and Passports:** You are responsible for obtaining all necessary immunisations and visas and bear the expense for the same. World Expeditions staff are able to advise you about visa but you must consult your General Practitioner or Travel Doctor for immunisation and helath advice. You must have a valid passport, which has at least six months validity beyond your return date.

**12. Exclusions from package price:** The following items are not limited to or included in the participation fee: Visas and passport charges; any additional charges resulting if not departing from Darwin (this includes any additional accommodation required due to 'forced' stopovers on your journey to or from Darwin); ticketable & non-ticketable airline departure, airport and airline taxes; extra meals not included in the itinerary; laundry, postage, personal clothing, medical expenses and items of a personal nature; aerated or alcoholic beverages; emergency evacuation charges; excess baggage charges; travel insurance; tips; any pre or post tour arrangements; single accommodation as all prices are twin share.

## 13. Assumption of Risk

You acknowledge that:

\* by the very nature of adventure travel, trekking & cycling holidays, they are more challenging and demanding with a commensurately higher level of risk compared with conventional holidays; and

\* in the countries and regions in which adventure travel is undertaken, standards of accommodation, transport, health care, hygiene, safety and service provision generally are often not as high as those standards in your country of residence and may require flexibility and patience on your part; and

\* operational control of the tour may be in the hands of a third party and that your right of action in regard to any shortcomings of that third party's performance is against the third party and not against World Expeditions; and

\* the additional dangers and risks associated with adventure travel may include difficult and dangerous terrain; high altitude; extremes of weather, including sudden and unexpected changes; political instability; remoteness from normal medical services and from communications; and evacuation difficulties in the event of illness or injury; and

\* the enjoyment and excitement of adventure travel is derived in part from the inherent dangers and risks associated with adventure travel and that those inherent dangers and risks are a reason why you wish to undertake the adventure tour, and

\* you have submitted your booking for the tour after giving due consideration of relevant travel information including, without limitation, any relevant information or advice given by the government of Australia and that it is your responsibility to acquaint yourself that information or advice, for the above reasons you therefore accept the inherent and increased dangers and risks associated with the proposed adventure tour and the accompanying risk of injury, death or property damage or loss.

## WAIVER OF LIABILITY

**14. Responsibility / Liability:** THIS IS VERY IMPORTANT, PLEASE READ CAREFULLY By my signature as set forth on the Trip Booking Form (reverse side of this form) I acknowledge and confirm the following: TO:, AUSTRALIAN WORLD EXPEDITIONS PTY LTD (WE) and the various Land Management Authorities who grant the license to operate this adventure trip being the Licensor: In consideration of WE accepting my application for, and being permitted to go on the adventure trip in the land owned and /or operated in by the Licensor or elsewhere, I agree to this release of claims, waiver of liability and assumption of risk (collectively, this Agreement). The Trade Practices Act, 1974 and the Victorian Goods Act, implies into the contracts for the supply of goods and services certain non-excludable conditions and warranties. Except to the extent that I have non-excludable rights under the Trade Practices Act, 1974 and the Victorian Goods Act, I waive any and all claims I may now and in the future have against, and release from all liability and agree not to sue Youth Off The Streets or WE and their officers, employees, guides, agents or representatives (collectively its staff) or the Licensor for any personal injury, death, property damage, or loss sustained by me as a result of my participation in an adventure trip with WE, due to any cause whatsoever, including without any limitation, negligence on the part of WE, its staff and Licensor, or death/ injury as a result of war, civil unrest or epidemic. I am aware that your adventure trip, in addition to the usual dangers and risks inherent, has certain additional dangers and risks, some of which may include: physical exertion for which I may not be prepared; weather extremes subject to sudden change ; that these inherent risks contribute to such enjoyment and excitement, being a reason for my participation. I agree that if I suffer injury or illness WE can, at my cost, arrange medical treatment and emergency evacuation service, as WE deems essential for my safety. In entering into this Agreement, I am not relying on any oral, written nor visual representations or statements by WE or Youth Off The Streets or their staff or any other inducement or coercion to go on an adventure trip, hence, only of my own free will. I confirm that I have read and understood the terms and 'Conditions of Contract' and this Agreement prior to signing it and agree that this Agreement will be binding upon my heirs, next of kin, executors, administrators and successors. I agree that this Agreement shall be governed in all respects by and interpreted in accordance with the law of New South Wales AUSTRALIA. NSW Travel Agents Lic Number 2TA001418.

Further to this, I also agree and understand that as I will be volunteering my service to do community work at the orphanage supported by Youth Off The Streets in Baguia, Youth Off The Streets will be required to conduct a criminal history check and I am also willing to sign a working with children declaration.
